



**NOTICE OF PROPOSED SOLE SOURCE PROCUREMENT**  
**this is not a competitive bid/proposal**

The Utah Transit Authority (UTA) Procurement Policy provides that sole source procurements may be used only when the Award of a Contract is infeasible under other source selection methods, and at least one of the following circumstances applies: (a) The required goods or services are of a specialized nature requiring expertise that is only available from a single source; (b) The public exigency or emergency for the required goods or services will not permit a delay resulting from competitive solicitations; (c) After solicitations of a number of sources, competition is determined inadequate.

The UTA Purchasing Department has received a request to make the following sole source procurement:

**Product and/or Service to be purchased:** CAD/AVL (Computer Aided Dispatching) and MDC (Mobile Data Computer) Software Development

**Contract Duration:** December 31, 2018

**Proposed Sole Source Supplier:** Software Technology Group (STG)

**Estimated Total:** Not to Exceed \$195,000

**Sole Source Justification:** Troy Fillerup, a consultant through STG, has performed work for UTA over the last 12 years. Mr. Fillerup has intimate corporate knowledge of UTA and has assisted in the software development services specific to CAD/AVL (Computer Aided Dispatching and Automated Vehicle location). In addition, he has specific background and experience with much of UTA's existing IT equipment including Motorola iDEN radio, GPS, digital signage, Automated Passenger Counters, Transit Signal Prioritization devices (Bus Rapid Transit), and peripherals.
