

## NOTICE OF PROPOSED SOLE SOURCE PROCUREMENT this is not a competitive bid/proposal

The Utah Transit Authority (UTA) Procurement Policy provides that sole source procurements may be used only when the Award of a Contract is infeasible under other source selection methods, and at least one of the following circumstances applies: (a) The required goods or services are of a specialized nature requiring expertise that is only available from a single source; (b) The public exigency or emergency for the required goods or services will not permit a delay resulting from competitive solicitations; (c) After solicitations of a number of sources, competition is determined inadequate.

The UTA Purchasing Department has received a request to make the following sole source procurement:

Product and/or Service to be purchased: Video Interviewing Software

**Contract Duration:** 24 months

Proposed Sole Source Supplier: HireVue

**Estimated Total:** \$151,350

Sole Source Justification: HireVue has been identified as a "Sole Source vendor" for the following reasons:

Over the past year HireVue has shown major efficiencies in our hiring process. With this software our average initial interview completion time dropped from 10 days to 3.1 days. Additionally, managers are evaluating interview at a much faster rate (3.5 days). Choosing another vendor will have major budget implications as we would need to build data integrations with other vendors which have a budget cost attached to it. HireVue contains a lot of our data which includes videos, interview questions and answers and evaluations.
