The "I Choose to Ride UTA" Award is presented during UTA's annual American's with Disabilities Act (ADA) Celebration to honor individuals with disabilities who choose to use UTA's accessible fixed route bus and rail services as their opportunity to achieve independence through mainstream, integrated public transit.

This year's award winners will be honored at the annual UTA ADA Celebration set for Thursday, July 26, 2018. The event, sponsored by UTA and its community advisory group the Committee on Accessible Transportation (CAT), is our opportunity to recognize progress in public transit options since the passage of the ADA in 1990.

The Celebration will be run from 4:00-5:00 p.m. and be located at the UTA Frontline Headquarters located at 669 W. 200 S., Salt Lake City. The program for the Celebration will include a review of UTA's on-going accomplishments to provide quality, accessible services to all customers while remaining compliant with ADA guidelines.
