The “Going the Extra Mile” Award, awarded each year during UTA’s annual American’s with Disabilities Act (ADA) Celebration, is created to honor UTA employees or contractor staff who provide outstanding customer service to people with disabilities. Eligible individuals can be nominated in recognition for either one specific outstanding incident of exceptional service or for providing consistent, day-to-day, friendly service that goes above and beyond expected performance and service standards.

The employee you nominate could work for any of the UTA public transit business areas such as route planning, paratransit trip scheduling, operating a bus or train, maintenance on vehicles to keep them operating safely and efficiently, or serving as a transit officer, train host or a customer service representative. Here is your chance to tell someone – YOU make a difference! Great job!

Employees selected for this recognition will be honored at the annual UTA ADA Celebration set for Thursday, July 26, 2018. The event, sponsored by UTA and its community advisory group, the Committee on Accessible Transportation (CAT), is our opportunity to recognize progress in public transit options since the passage of the ADA in 1990.

The Celebration will run from 4:00-5:00 p.m. and be located at the UTA Frontline Headquarters located at 669 W. 200 S., Salt Lake City. The program for the Celebration will include a review of UTA’s on-going accomplishments to provide quality, accessible services to all customers while remaining compliant with ADA guidelines. Award winners will be honored and presented with personalized certificates and gift packages as part of their recognition from UTA and the CAT.
